The bidder submitted an invalid certified copy of the Affirmative Action Compliance Certificate or proof from the Employment Equity Commissioner that the bidder is not a relevant employer or exemption issued in Section 42 of the Affirmative Action Act, 1998, certified by the commission of oath and not by Namibian police as required in the bidding documents.  The bidder Submitted an invalid certified copy of the CRAN license as proof that the bidder is registered with and regulated by the Communication Regulatory Authority of Namibia (CRAN), certified by the commission of oaths and not by Namibian police as required in the standard bidding documents.

# 9. Technical Evaluation Summary:

### **Bidder 1 - Mobile Telecommunication (MTC)**

- The medium for proposed solution is fibre, which is the medium preferred by NUST.
- No organogram chart attached resulting in the bidder scoring 0 points for that section.
- The bidder scored 95% of the technical evaluation scores overall.
- The bidder qualified for the financial evaluation.

# Bidder 2- UCOM Mobile Namibia (Pty) Ltd

• The medium for the proposed solution is microwave and therefore not the medium preferred by NUST.

- The bidder provided a comprehensive work plan but lacking substantial working methodology and it scored 5 points for that section.
- The bidder scored 80% of the technical evaluation scores.
- The bidder did not qualify for the financial evaluation because the solution quoted is not that of the preferred medium which is fibre or cable.
