- The bidder failed to submit a detailed company profile and therefore scored of 0% at that section.
- The bidder provided two (2) contactable references and scored 15% instead of the full points.

## Bidder 6: Hungwe Civil Engineering & Construction CC

- The bidder scored 55% of the overall technical evaluation.
- The bidder did not submit of CV of Contract Manager for this contract, therefore scored 0% for that section.
- The bidder did not indicate its response time after the Order Placement and scored 0% for that section.
- The bidder provided two (2) contactable references and scored 15% for that section.

## **Bidder 7: Advance Cabling Solution CC**

- The bidder scored 30% of the overall technical evaluation.
- The bidder did not submit of CV of Contract Manager for this contract, therefore scored 0% for that section.
- The bidder indicated two (2) weeks delivery of its response time after the Order Placement and scored 15%.
- The bidder did not submit a detailed company profile, therefore scored 0% for that section.

- The bidder did not attach proof of three (3) contactable reference and scored 0% for that section.
- The bidder did not submit the key personnel experience indicating three (3) years' experience and scored 0% for that section.
- The bidder did not provide its organisational chart indicating key personnel.

#### Bidder 13: H.L.S Investment CC

- The bidder scored 85% of the overall technical evaluation.
- The bidder only provided two (2) contactable references and scored 15% for that section.
- The bidder has bid 90% of the item quoted, as they did not quote for PDU, and therefore then scored 10% instead of the full 20%.
